1. What are the Coastcare Victoria Community Grants?


The Victorian Government is providing funding to the annual Coastcare Victoria Community Grants. The grants fund community-led environmental groups and organisations that deliver projects to support the community in caring and acting for the marine and coastal environment.

The Coastcare Victoria Community Grants implement the [Coastcare Victoria Strategy 2021-26](#) actions to:

- conserve, restore and protect Victoria's coastline
- promote marine and coastal volunteering and participation
- support community engagement and education to enhance knowledge and understanding of marine and coastal management
- expand, diversify and increase the inclusivity of volunteering
- recognise Traditional Owners' longstanding connection to Country and support their role in leading healing and ongoing care of Country
- support two-way capability building to strengthen relationships and foster shared understanding between marine and coastal volunteers and Traditional Owners.

What are the project streams?

Up to \$10,000 ex GST of grant funding is available for projects focusing on one of three streams.

2. Who can apply?

The following applicants are eligible:

- Community-led environmental groups and networks
- Non-government environment-focused organisations
- Registered Aboriginal Parties
- Aboriginal groups and organisations
- Committees of Management (excluding Local Government)

All applicants must meet the following financial governance requirements:

1. Registration/Incorporation via one of the following:
 - [Australian Charities and Not-for-profits Commission](#); OR
 - [Consumer Affairs Victoria](#) / other state incorporating agency; OR
 - [Crown Land \(Reserves\) Act 1978](#); OR
 - [Registered Victorian Aboriginal Party](#)
2. Insurances to cover the duration of the project:
 - Hold public liability insurance of at least \$20 million; AND
 - Volunteer personal accident insurance

Applicants who are not eligible can still apply for funding but must operate under an Auspice organisation (see [Additional Information](#)).

3. Who cannot apply?

The following applicants cannot apply for funding:

- Local, State and Commonwealth Government (including all bodies and authorities)
- Private individuals, commercial organisations and bodies, foundations or trusts
- Water and Catchment Management Authorities

4. What projects and expenditures might be funded?

All projects must meet the eligibility requirements and provide all applicable supporting documents to be eligible for funding:

- Projects must be undertaken on, or relate to, *marine and coastal Crown land*, as defined in the [Marine and Coastal Act](#) as 'the outer limit of Victorian coastal waters and 200 metres inland of the high-water mark of the sea', or 'reserved under the Crown Land (Reserves) Act 1978 for the purposes of the protection of the coastline'
- Applicants must contact a Coastcare Victoria Officer to ensure the project meets the eligibility criteria and project requirements
- Applicants must have consulted with the Land Manager for any components and/or activities undertaken on marine and coastal Crown land to ensure:
 - review and support of the application
 - identify requirements for application for consent under the [Marine and Coastal Act 2018](#)
 - alignment with the objectives of the relevant coastal and marine management plan
 - compliance with government policies and relevant legislation.

What projects might be funded?

The following types of projects are eligible for funding across three streams.

Stream 1

Coastcare Victoria Stewardship and Education

Projects that engage a broader audience in on-ground action and education to enhance knowledge of the coastal and marine environment. This may include:

- on-ground actions to conserve, restore and protect the environment
- weed control and revegetation
- threatened species recovery
- heritage protection through site assessments, awareness and shared history discussions
- education and engagement opportunities through community events and activities
- citizen science activities
- projects that utilise the Coastcare Victoria Schools Kit

Stream 2

Strengthening the Coastcare Victoria Community

Projects that increase participation in the Coastcare Victoria community into the future. Engaging new and diverse coastal volunteers and supporting the Coastcare Victoria stewards to build capability and inclusivity, including:

- participation opportunities such as events and activities
- education opportunities
- increase the diversity and inclusivity of coastal volunteers by including people of all abilities, ages and backgrounds
- “Reimagine volunteering” to attract more / different participants and volunteers e.g. flexible, casual, event-based or short-term volunteering
- creating new partnerships and connection opportunities to expand the volunteer base

Stream 3

Caring for Country

Projects that celebrate Traditional Owner Self-Determination in caring for Land and Sea Country and recognise Traditional Owners longstanding and deep knowledge and connection to Country. Supporting two-way capability and capacity building, including recognition and support of:

- Traditional Owners' role in leading healing, ongoing care and custodianship of Country
- Traditional Owners' role in restoring marine and coastal cultural knowledge and practice
- improving the shared understanding and working relationships between volunteers, Traditional Owners and other marine and coastal land managers
- self-determination of Traditional Owners' vision for marine and coastal Country through supporting action on Traditional Owners' Country Plans
- heritage protection through awareness, shared history discussions and site assessments

What expenditure items might be funded?

Please ensure assets and equipment are hired, borrowed, and shared between rather than purchased for one-off projects where possible.

Quotes for expenditures over \$2,000 are required at the application stage, and capital items must become an entity's registered asset. Expenditure items eligible for funding:

- communication, including advertising, marketing and promotion
- environmental and technical advisors, contractors and specialists (must be from an external party or provide a declaration of conflict of interest at the application stage)
- equipment or asset purchases/hires/lease
- fees and permits
- insurance renewal or organisation membership renewal that includes insurance cover
- on-ground project materials for site preparation and protection, weed control and revegetation
- project management and administration (maximum 15% of total funding)
- project volunteer care and protection, including catering, PPE, weather protection and safety requirements
- fees and permits
- sustainable education materials
- training and certification (if directly related to funded activity)

5. What projects and expenditures will not be funded?

What projects will not be funded?

The following types of projects are ineligible for funding:

- actions or costs associated with native vegetation offset sites or activities
- amenity and beautification projects
- clearing vegetation without Land Manager consent and appropriate permits
- infrastructure or asset projects such as coastal protection structures, sand renourishment and erosion mitigation
- pest animal control
- planting non-indigenous flora species

What expenditure items will not be funded?

The following types of expenditure items are not eligible for funding:

- IT equipment computers, laptops, tablets and smartphones
- goods or services for competitions, prizes, gifts, vouchers or alcohol
- chemicals or hazardous materials

Note: products produced from Victorian Government funding, including Coastcare Victoria, cannot be sold or reproduced for money.

6. What are the assessment criteria?

Assessment criteria and weighting

Applications will be checked for eligibility for the applicant and project. Eligible applications will be assessed using the criteria and weighting below. Each criterion is given a percentage weighting to indicate its relative importance in the assessment process. Applications should address all relevant criteria.

Projects that achieve higher scores based on the criteria outlined below are more likely to receive funding. Consideration may also be given to the overall balance of project types, streams, diversity, inclusivity, geographic distribution, and alignment with the Victorian Government's commitment to Traditional Owner self-determination.

7. What are the grant funding details?

The Victorian Government is investing up to \$220,000 through the VicCoasts volunteer program to sustain the Coastcare Victoria community. The funding, part of the Victorian Budget 2024/25, aims to support the community in acting and caring for Victoria's marine and coastal environment.

In-kind support	Applicants are not required to contribute (cash or in-kind) toward the project's cost; however, a project that can demonstrate contributions provides greater value for money to Coastcare Victoria and may receive a higher score against the Value for Money assessment criteria.

8. What supporting documents will need to be provided?

All applicable supporting documents must be provided for the application to be assessed. Failure to provide the required documents will make the application ineligible. Correspondence, such as letters and emails, will be accepted as supporting documents.

The application **must** include:

- A copy of Public Liability Insurance of at least \$20 million and Volunteer Personal Accident Insurance
- Letters of support from Auspice Organisation (if required)
- Letters of support from Land Manager (if required)

The application **may** include:

- Letters of support from project partners
- Any documents supporting the project outcomes, activities, risks and actions, including maps, photos, and plans
- Documents supporting the project expenditure (including quotes for items over \$2000)
- A declaration of Conflict of Interest if an external contractor has a relationship with the applicant

A project that can demonstrate the project's outcomes to Coastcare Victoria may, therefore, receive a higher score against the assessment criteria. Supporting document templates and resources:

9. What are the funding conditions?

Acknowledging the Victorian Government's and Coastcare Victoria's funding support

Funding recipients are required to acknowledge the Victorian Government's and Coastcare Victoria's funding support in all project activities, including printed and published materials and in verbal communications at events and activities.

When acknowledging the funding support, approval must be sought from the Coastcare Victoria team. Further information: [Acknowledgment and Publicity Guidelines for Victorian Government Funding Support](#)

Funding agreements

Successful applicants must enter a Victorian Common Funding Agreement with the Department of Energy, Environment and Climate Action (DEECA). It is recommended that applicants review the terms and conditions before applying. Information is available at <https://www.vic.gov.au/victorian-common-funding-agreement>

The activity does not include using the Funding for political campaigning or advocacy activities for political parties.

If the project is funded, successful applicants must provide all applicable documents before the project can commence:

- attend a project meeting with a Coastcare Victoria Officer
- Land Manager approved Job Safety and Emergency Plan (or equivalent)
- Land Manager submitted Marine and Coastal Act 2018 consent application.
- approval for appropriate works permit/s from councils or other authorities
- any permits/consents required by government policies and relevant legislation (including Marine and Coastal Act 2018 consent if applicable)

Payment

Agreed payments will be made as long as:

- the funding agreement has been signed by both parties
- other terms and conditions of funding continue to be met.

Tax implications

Applicants should consult the Australian Taxation Office or seek professional advice on any taxation implications arising from this grant funding. Funding recipients without an ABN will need to provide a completed Australian Taxation Office form 'Statement by a Supplier' so that no withholding tax is required from the grant payment.

Monitoring & Reporting

Grant recipients must comply with project monitoring and reporting requirements as outlined in the funding agreement. This includes providing supporting documents, project meetings, job safety plans, completion reports, and budget acquittal documentation.

Privacy

Any personal information about you or a third party in your application will be collected by the department for the purposes of administering your grant application and informing Members of Parliament of funding recipients. Personal information may also be disclosed to external experts, such as members of assessment panels, or other Government Departments for assessment, reporting, advice, comment or for discussions regarding alternative or collaborative grant funding opportunities. If you intend to include personal information about third parties in your application, please ensure that they are aware of the contents of this privacy statement.

Any personal information about you or a third party in your correspondence will be collected, held, managed, used, disclosed or transferred in accordance with the provisions of the *Privacy and Data Protection Act 2014* and other applicable laws.

Auspice information

Applicants who are not eligible can still apply for funding but must operate under an Auspice organisation that meets the eligibility.

An Auspice organisation will be required to enter the Common Funding Agreement and agree to provide:

- financial management of the grant funds
- public liability insurance of at least \$20 million and volunteer personal accident insurance to cover the project's duration
- accountability for project deliverables and acquittal
- responsibility for the project's occupational health and safety requirements
- a letter of support from the Auspice organisation agreeing to auspice the project application
